## Finance Committee Meeting Minutes Thursday, March 31, 2022

## Article 4 - FY 22 In-Year Budget (1:30)

Capital Budget Committee Chair Ed Forsberg presented the two capital budget items in question. The first is a request for \$450,000 to replace an ambulance and the second is to purchase 9 defibrillators.

Jim Johnson stated that the ambulance replacement was originally scheduled later but is being moved up in an attempt to avoid rising prices and supply-chain issues. Fire Chief Timothy Bailey stated that ambulances are typically supposed to be replaced every three or four years.

Ed Forsberg stated that new defibrillators are needed in various public spaces. Josette Burke asked about lifespan of units and Director of Public Health responded through Jim Johnson that defibrillators have a lifespan of 8-10 years and the batteries should be replaced after 4 years. Mark Sullivan questioned how many lives defibrillators actually save.

### Article 10 FY 22 Snow and Ice Budget (23:10)

Town Administrator Jim Johnson recommended no action on Article 10.

## Article 11 Stabilization (24:12)

Town Administrator Jim Johnson recommended no action on Article 11.

**(20:40) Motion** by Dennis Crowley and seconded by Susan Lawson for **no action on Article 11.** The motion passed 12-0-0.

### **Article 12 OPEB (24:55)**

Town Administrator Jim Johnson recommended no action on Article 12.

**(25:20) Motion** by Dennis Crowley and seconded by Susan Lawson for **favorable action on Article 15.** The motion passed 11-1-0 (Lawrence Pitman no)

## **Article 16 Personnel Board (28:30)**

Mark Trudell explained that this article would change the language in the Town Charter to essentially dissolve the Personnel Board and award its responsibilities to the Select Board.

Lawrence Pitman stated that he served on the Personnel Board in the past and described the various actions the Board would typically take. He stated that the Personnel Board traditionally advocates on behalf of non-union positions during negotiations and disputes and opposed the article.

Susan Lawson argued that Personnel Board members have no special expertise and the Select Board could just as easily execute its functions. Jim Johnson described occasions where the existence of the Personnel Board slowed or stood in the way of progress. Brian Bain spoke in favor of the article because the Personnel Board has been rendered obsolete by other boards.

**(40:20) Motion** by Dennis Crowley and seconded by Susan Lawson for **favorable action on Article 16.** The motion passed 10-2-0 (Brian Bain and Lawrence Pitman no).

## Article 6-9 Sewer & Water Budgets (41:00)

Mark Trudell stated that the Finance Committee would attend the Board of Water & Sewer Commissioners' Public Rate Hearing on Monday, April 4<sup>th</sup>.

Article 6 is the FY 22 Water Budget, Article 7 is the FY 23 Water Budget, Article 8 is the FY 22 Sewer Budget, and Article 9 is the FY 23 Sewer Budget. None of the final amounts have been finalized yet.

Town Administrator Jim Johnson stated that the Board of Water & Sewer Commissioners have the ability to change their rates at any point in the year in the event that there is a budget shortage.

Treasurer / Collector Lisa Sinkus explained the process of how water usage is measured and billed to Walpole consumers.

The Finance Committee debated whether to make motions on Articles 6 - 9 or wait until after the Board of Water and Sewer Commissioners' Public Rate Hearing.
