5-25 Michael Yanovitch, seeking a change in the Building Department Fees

Mr. Johnson explained he has been working on this since he came back. Mr. Yanovitch I started it in 2014, something that has been put on the back burner, bringing the fee schedule up to date and using fees from other towns. I utilized towns with similar sizes and further fee structures and we were not the highest. Not impacting renovations significantly, multifamily housing is the largest increase. Dedham has increased their fees. This is what we came up with. We streamed lined gas, electricians.

Mr. Salvatore the proposed fee for residential is \$11 what is it know \$10. For commercial is \$15, and you are looking to go up to \$18 for multifamily.

Ms. Ragosta commercial and residential 3 units per more, \$18 per thousand, if you add the plumbing and gas fee where the 3 units would or more fall? Mr. Yanovitch there should be a list for plumbing or gas. Where would it show 3 units? Mr. Yanovitch it would be new commercial. If someone is going to build a 3 or more unit structure it is \$48 per thousand would be there fee. Ms. Ragosta what if it is a 5million dollar project? Mr. Yanovitch it would be \$20,000 for plumbing and gas.

Mrs. Salvatore for the main permit do you pay for the sub trades? Mr. Yanovitch that is the most common practice. The sub trades pay on their individual fees as well. Mr. Salvatore lets say you are paying to renovate your home. Mr. Gallivan most of these can be applied for online. Pushing for an easier permit process. Mr. Gallivan I think that is a great idea. Make it easier for people is a good thing. Talked about tents and signs.

Mr. Salvatore what tent are you talking about? Mr. Yanovitch Large tents for events that come up. Mr. Salvatore what about temporary signs? It is for establishments that are waiting for their signs to be made. This is an average for what people pay. Some do not get charged at all.

Mrs. Mackenzie a temporary sign could be a banner for a business. Temporary signs for businesses that do not have their signs up yet. Mr. Yanovitch It gives us leverage for people that don't take their sign down when they have gone beyond the time.

Ms. Ragosta why do we charge for signs? Signs are in the building code. We charge because we have to review the plan. When the sign is installed the electrical inspector goes out and inspects.

The Sewer and Water commission are still vetting this process and this is ready to go. David owner is here with Counsel. Mr. Salvatore the MWRA has to approve. Mr. Johnson yes because it shares a portion of the hotel is in Sharon. Mr. Salvatore so they are reviewing sewer. Mr. Gallivan explained we are talking about the Applebee's site.

Ms. Ragosta, I am opposed to this I think this is bad for Walpole, as we are allowing another town to connect to our water. We already restrict what the residents in Walpole use. We charge more to those that use more water. Large volume users. We do that to those that use a lot of water. Mr. Johnson explained this agreement covers responders, two sets of standards, including zoning. Ms. Ragosta my concern is allowing a Sharon business to use our water.

Mr. Salvatore has sewer and water have they said yes. Mr. Johnson noted they have not authorized anything yet. So they have not approved it yet. Their process is different than our process.

Attorney Joanna Giorgio Hilvert, to clarify, the intermuniciapl agreement is primarily with zoning, the hotel because is straddles the town line, there will be water restrictions, the portion of Sharon. That is a separate process. We have met with Rick Mattson, to infrastructure improvements. This is more the permitting part. The sewer and water have their own agreements. The permitting fees close to one million in sewer fees. The entrance is in the Town of Walpole.

Mrs. Mackenzie I think Mr. Johnson did a great job for Walpole. We talk about being business friendly; we are getting above what we would get if it was just a regular hotel. We are talking about taxes.

Mr. O'Neil are we giving anything up. Are we treating them equally to everyone else in town? Mr. O'Neil so there is no down side. That is what I thought; I want to make sure we clarify. This agreement worked out well for us.

Mr. Gallivan thinks it is a good Project for Walpole.

Owner we are trying to get into this market. My background is environmental, I am a planner. This hotel, we are putting solar panels on the roof and sheds to park the cars. We are going to put in 5 charging station. Recycling grey water, dealing with the stretch code. Being Lead certified. I did the outlets in Wrentham.

Mr. Salvatore how is this tax going to be collected. Mr. Johnson we have to bill Sharon for their portion of it. Are the rates the same? What is the rate for the tax? Mr. Johnson it is at 6.2 percent.

Owner I have been doing this since 1969. The staff, the fire, police have worked very well with their counter parts.
