End of Fiscal 2021

Jodi and her team are wrapping things up and planning on closing out the books two days from now. Once done she will begin the process of certifying the free cash and retained earns from sewer & water; just need to get a few final bills paid. I'm optimistic we will have some certified numbers by mid to late August.

Capital Budget

Department Heads have submitted capital requests and I'm working to organize and review each of the requests. Once we have free cash certified, I'll finalize my recommendations for Capital Budget to consider.

Fall Town Meeting Warrant

Currently we have 15 articles and most relate to capital budget with three borrowing articles. I do expect under Article 2 some changes to the Town Clerk's budget; which I expect for the special election, approximately \$25,000-\$30,000.

And then what we discussed a few weeks ago about with the East Walpole Fire Station; I may make an adjustment under that budget.

Norfolk County

The County just issued a letter, saying they have decided to administer the funds, Walpole's share is about \$6million. I have asked for an exact figure and the rules and guidelines and when we can get them a list of projects. As far as COVID funds that came directly to the Town it was just about \$2.5-2.9million, we are still working through the guidelines but our capital list is very extensive so we will have a large laundry list. We just have to make sure we adhere to the guidelines that are established.
