Appointments

Call to Order and Pledge of Allegiance

Chair O'Neil called the meeting to order at 7:00pm followed by the Pledge of Allegiance.

Mary Jane Lightbody, South Walpole Traffic Response

Resident Mary Jane Lightbody was present to discuss the Town's response to Gillette Stadium event related traffic. Chair O'Neil outlined the issues that occurred recently with the concert traffic in South Walpole. Mary Jane thanked everyone for their efforts during the last series of concerts and hoped that similar methods would be utilized for future events. Jim Johnson informed the Board that WPD worked hard with Waze, Google maps, news outlets and social media as well as additional police presence in the area, which helped decrease congestion in residential areas and will utilize the same strategy for upcoming events. The Board thanks the Town staff, Police Department and residents for the great collaboration.

Show Cause Hearing May Wah Inc. dba Kihei Dynasty, 743 Main Street. (Continued from April 26, 2022)

Chair O'Neil informed the Board that the license holder has surrendered the license back to the Town so no additional action needs to be taken by the Select Board. On motion of Clerk Hamilton, seconded by Vice Chair Maffei, voted to close the public hearing. Motion Passed (4-0-0).

Peter Frazier, Hilltop Securities: Discussion and Possible Vote on Middle School Project Borrowing Options

Peter Frazier, Hilltop Securities Managing Director, Finance Director Jodi Cuneo and Treasurer/Collector Lisa Sinkus were present. Chair O'Neil touched on the previous borrowing that occurred towards the end of last year and how the Board are now looking towards the second stage of the borrowing for the Middle School project. Peter stated that because interest rates may continue to rise, it might possibly be smarter to borrow more money now at the current rate. Finance Director Jodi Cuneo agreed that borrowing sooner rather than later would mitigate the risk of potentially higher interest rates down the line. A lengthy discussion occurred among the Board members in terms of the uncertainty that exists with fluctuating interest rates, the pros and cons of borrowing early and the overall cost to the residents.

On motion of Clerk Hamilton, seconded by Vice Chair Maffei, voted to direct the Town Administrator, the Treasurer/Collector and the Finance Director to move forward with a \$20million borrowing this month for the middle school project. Motion Passed (4-0-0).

Discussion and Vote on date and location of Fall Town Meeting

Town Clerk Elizabeth Gaffey was present. Town Administrator Jim Johnson stated that opinion was split on whether to keep Town Meeting on a Saturday morning or go back Monday nights. Clerk Hamilton stated that she had heard from members about scheduling difficulties with the recent Spring Town Meeting being held on a Saturday due to

conflicts. The rest of the Board agreed that it was time to return to Monday night Town Meetings, as is designated by the charter.

On Motion of Clerk Hamilton, seconded by Vice Chair Maffei, voted to hold this year's Fall Town Meeting on Monday, October 17 beginning at 7:30 P.M. at the Walpole High School. Motion passed (4-0-0).

Capital and ARPA Discussions (votes may occur)

Walpole Housing Authority Board of Directors member Judy Conroy was present to request that the current Johnson Middle School be repurposed as a site for affordable housing for low-income households, seniors, and/or veterans. She suggested that the Select Board appoint a Johnson Middle School Repurpose Sub-Committee, and to approve a feasibility study and an RFP for the project. The Board agreed that it would be wise to put together a group with representation from different interested parties to determine the best options for the re-use of the Johnson Middle School.

School Committee Members Nancy Gallivan and Sean Ahern, Superintendent Gough and Business Administrator Friscia attended to present budget requests for Capital and ARPA funds. Requests included funding for new technology, designs and construction of a building project at the high school, and HVAC upgrades. The School Committee delegation outlined that although there is a significant need for expansion to the preschool program, there are other projects that must take precedence such as the new Middle School.

The Board thanked everyone for attending tonight and for bringing these items forward. Jim outlined that at the next meeting with a full Board he will need some direction in terms of use of ARPA funds. Chair O'Neil informed the Board that a discussion would likely take place at the next meeting with the Sewer & Water Commissioners to discuss a number of items in terms of their requests. The Board agreed that it was a good idea to have that discussion.
