There is also a typo that needed correcting. **Motion Made** by William Abbott to accept the minutes of June 8, 2015 with the suggested correction being made. Second by John Spillane. Vote 4-0-0.

There is one correction suggested to the June 22, 2015 minutes. **Motion Made** by William Abbott to accept the minutes of June 22, 2015 with the one amendment. Second by Tom Brown. Vote 4-0-0.

**REQUEST FOR CONSIDERATION , DOUCETTE, 387 HIGH PLAIN ST.**

The letter sent by Jamie Doucette requesting consideration for a high water/sewer bill due to a running spigot is reviewed and discussed as well as the backup information provided by the Water Department. **Motion Made** by John Spillane to abate \$654.58 of sewer charges as calculated by the Water Department. Second by William Abbott. Vote 4-0-0.

**SEPTAGE FACILITY EVALUATION**

There is discussion and the Board decides to wait until the Superintendent returns from vacation to see what option he prefers.

Mr. Joe Grant from the Jarvis Farm Committee is present and asks to speak with the Board. He presents a proposal to use the Farm for a triathlon for children on August 30. He reviews his ideas for obstacle courses for different age groups with the Board and there is discussion. Mr. Spillane asks what if someone gets hurt and Mr. Grant says he has been talking with Tom Gregory, Asst. Town Administrator. They are planning to hire an EMT and the program would be run through recreation and their standard disclaimer would be used. There would also be an certificate of insurance from the partnerships. Mr. Abbott asks if the rest of the committee has seen this proposal and Mr. Grant says he spoke to them at their last meeting and all seemed to be in favor of it. Clean up, prices and parking are also discussed. Mr. Grant says the pond will not be used. He is looking to make it an annual thing. **Motion Made** by John Spillane to support Mr. Grant's proposal of a triathlon at Jarvis Farm on August 30<sup>th</sup>. Second by Tom Brown. Vote 4-0-0. Mr. Turner asks that this Board be kept up to date.
