The Zoning Board is requesting comments for a comprehensive permit 40B application for the above referenced address. The proposed project includes the construction of 24 townhouse units with associated utilities and parking. The proposed project would utilize town water and town sewer. The Health Department made internal comments on this project on July 26, 2022. The Health Department recommended that adequate lighting is provided throughout the development and that bike racks are included to promote a healthy lifestyle. The Health Department also requested that separate containers for both trash and recycling be provided for residents in compliance with the Massachusetts Waste Ban. The revised plan includes a bike rack and the expansion of the dumpster pad enclosure to provide adequate space for both trash and recycling containers. The applicant also noted that a photo metrics plan was not included in this submission but will be supplied later.
