Verizon Cable Contract Funds

Balance in the Verizon Cable Contract Funds is \$120,000, Capital Budget Committee is requesting \$45,000 for the Munis Server & Software Upgrade for the IT Department and \$10,000 for Video Equipment for the Recreation Department. No other appropriations being requested from this account at this time. Town Administrator spoke to negotiations will be commencing shortly with Comcast.

Snow Funding Update

Budget is in deficit in the amount of \$239,000, to date \$147,000 has been spent in overtime, \$727,000 in expenses of which the largest share is for contract plowing, there are still bills coming in. He hopes that the Town will receive some reimbursement for these winter storms. Average snow storm costs \$150,000. C. Timson requested that an analysis be done on the expenditures for various years on the storm costs and the cost per inch per contract, Town Administrator will look into it.

Health Insurance – Rates have been set at 7%, he had hoped for a larger percentage, only saved \$5500.

Budget Update, anticipated increase of \$338,810 due to changes in tax levy, Norfolk County Retirement and Health Insurance. He is proposing adding an additional monies to the School Budge, Town Clerk, Building Maintenance, Veteran's Benefits and Library. It will be up to the Selectmen and FinCom on the allocations of these funds. He will also be asking for an Executive Session for contractual services under the Legal Budget at the next meeting.

Old Business

C. Timson spoke contract negotiations with employees, that raises could potentially be based on revenues, and if there is money available, maybe have bonuses. He is not looking to get rid of collective bargaining. Feels there is the need to be fair to the employees. Town Administrator spoke to this being a strategy for executive session and with a full board, there needs to be changes at the state level.
