A regular meeting of the Board of Sewer & Water Commissioners was held on Monday, March 13, 2023 at the Town Hall, 135 School Street, Select Board Meeting Room. The meeting is called to order by Board Chair John Hasenjaeger at 6:30 p.m.

#### **Appointments**

**1.** 7:00 North Walpole Residents' Interest in Sewer Connection (Emails) Mr. Hasenjaeger explains to the residents in attendance the reasoning behind the meeting. Mr. Abbott presents the proposed extension and ballpark costs for the impacted residents.

**Resident**: Raised a question regarding the degree of confidence in the estimate. Mr. Mattson explains that construction costs have been rising between 3% and 5% annually.

**Resident from 589 High St**: Raised a question on betterment with regard to selling your home. Her understanding is that if a betterment is not paid before selling the house, the homeowner has to pay the betterment in full before they sell, otherwise a lien is put on the house. Discussion is had in this regard with the Board members.

**Resident**: When was the last time a project was done like this? Mr. Hasenjaeger explains that this was a project that was proposed for Hitching Post Drive but the residents turned it down.

**Resident**: Would the town allow a second meter for irrigation?

Mr. Abbott responds that it is allowed. A second meter makes no sense for someone not on sewer, a second meter makes no sense.

**Mike Power, Chickering Ln:** Never able to get town water, he has a well. Where does that leave him? Mr. Abbott explains that there are other residents in the area in the same situation. Generally, the town would attach a meter on their well.

Richard Russo, Buckwood Dr.: Does the homeowner incur the cost of removal?

Board: Yes.

What would the approximate cost be to dig through his yard to connect to the lateral as his septic is under his deck in the rear of his home and he is on ledge in the front. Board: There are many variables.

**John Hatch**: Question regarding red zone. How are they collecting feedback on votes? Board: This is the first step and they can get a better idea with all residents in attendance what the "for" and "against" ratio would be.

**Mary Shaheen**: Concern that her neighbor also got the letter and they're not on sewer. Could it be fewer than 155 residents? Also, could they tie in to neighbors sewer lines on their own and not be a part of the project.

Patrick Fasanello explains background and history of MWRA and its benefits

**Bob Scrant, High St**: No interested, he doesn't want a lien on his property. Straw vote taken – the majority are opposed to the sewer program.

Eric Minkowicz, Mill Brook – Questioned the length of time and impact on traffic in the area.

Floreen Knight: If the plan were approved, ow long would it take before the project starts.

Dave Fordham, High St: Are any of the informational pamphlets handouts available online?

**Bob Ross, Ridge Rd**: Are there alternatives for people who need to replace their septic systems that are permitted by the Town and/or the state?

Further discussion had regarding undeveloped lots and the developer is able to vote for/against the plan for as many house as they have developed.
