Process for Abatement Signoffs

Representative from the Department addressed the Board regarding updating the process for abatements. *Motion made* by Mr. Abbott *Seconded* by Mr. Fisher to approve bill adjustments due to Board policies – washer/toilet rebates, rink/pool fills, sewer abatements and bill adjustments due to system errors/faulty transmitters, meter change-outs, estimation errors – all handled internally by the Water Department. *4-0-0 (YES VOTE)*
