Mr. Wiley requested this be kept on the Agenda but nothing else is new at the present time regarding the sale of the Buttimer Property.

DISCUSSION

ATLANTIC CT. EXTENSION

The commission discussed the owners request to include a trail and visual enhancement easement on Atlantic Ct. This land is to be donated under the approved definitive subdivision decision to the conservation commission. Ms. Hershey and the commission discussed comments received from Town Counsel with suggestions regarding verbiage in the quitclaim deed they reviewed after the last meeting. Board members completed a site visit of Atlantic Ct. to gain a better perspective. Mr. Viano gave a brief history regarding this property and the commission had a copy of the Planning Boards decision to refer to.

The commission discussed the need to focus on whether the Town would benefit with this gift, good forestry management, and the need for future guidance. The majority of the board agreed they would approve the granting of these easements, but would like Town Counsel once again to recommend verbiage and review with the Board. It was discussed the Town Bylaw be referenced in the deed as well.
