DISCUSSION PONDS COMMITTEE

The Ponds Committee members gave a power point presentation to the board. They are seeking a temporary management plan for 90 days to run activities at Turners Pond Lodge. Activities will include birthday parties, skating, campfires, educational classes and community involvement. They plan on using Turners Lodge as a home base. While the commission supports the enthusiasm of this group, the board discussed the need for the committee to keep the conservation commission apprised of the activities that are planned. The board also discussed that any physical changes or alterations to the pond and property is still under the management of the conservation commission, and the proposed changes need to be submitted in writing to them. The commission stated they support the efforts of the Ponds Committee in seeking money from the Capital Budget

A discussion was held regarding pond level and what the appropriate level is for winter months. The commission will further discuss this and get back to the Ponds committee.

Ms. Dyer made the motion to approve the issuance of a 90 day management plan for activities at Turners Pond to the Ponds Committee beginning immediately Mr. Finnigan seconded the motion Vote: 5-0-1 (Mr. Turner abstained)

Mr. Wiley read the advertisement from the Walpole Times and green cards were collected.

Mr. Wiley read Board comments into the record.

Mr. Marc Bergeron, project manager from VHB, Inc. was present representing NSTAR. The proposed activity consists of routine maintenance of existing access roads within a right-of-way located off High St. Mr. Bergeron stated this involves the placement of swamp mats which will be placed across vegetated wetlands. He also stated NSTAR would like a more uniformed roadway for safety and access. The wetlands have been flagged. Mr. Bergeron stated the work will take approximately one week and the mats will then be removed immediately. He stated straw wattles would be used for erosion control measures.

Commission members had no specific concerns regarding this project

Mr. Rich Kirby, of LEC Environmental stated this filing is for the construction of a single family dwelling with site appurtenances. Plans were presented "Lot 73 Resource Area plan of land in Walpole" dated 11/16/10. He stated a Determination of Applicability was approved and issued back in 2004 but has since expired and Toll Bros. is now ready to get underway with this project. He stated there is no proposed work to be done within the 100' buffer and erosion controls will be installed along the limit of work. Mr. Kirby is asking the commission for a Negative determination

The commission reviewed the letter received from the Board of Selectmen's Goals and Objectives. A specific discussion took place regarding the Pond Management Program. The board discussed working with the Ponds committee regarding programs and activities, while at the same time assuring the Walpole Wetlands Act and local Bylaw are in compliance

DISCUSSION

The commission continued the discussion regarding the appropriate water level for Turners Pond. It was decided there should be both a winter and summer plan. The commission feels two boards should be removed at this time dropping the pond 12 inches for winter conditions and potential flood control as well. A letter will be sent to the Ponds committee directing them of this decision

Ms. Hershey gave the commission a draft with an evaluation of Conservation land and is asking for feedback from the commission. The board will review the parcels via aerials, Google earth and GIS. The information should be cataloged.
