PUBLIC MEETING REQUEST FOR DETERMINATION OF APPLICABILITY HANCOCK CT. LOT 8A (#12)

Mr. Wiley read the advertisement from the Walpole Times. Green cards were collected

Mr. Wiley read board comments into the record.

Mr. Dan Merrikin, Merrikin Engineering was present representing the applicant. Plans were presented to the board entitled "Lot 8A Hancock Ct. Lot Development Plan of Land in Walpole, MA" dated June 2, 2012.Mr. Merrikin stated this filing is a Request for Determination of Applicability. The proposed activity includes the development of a vacant lot with a single family house, earthwork, landscaping and utility installation. Mr. Merrikin stated the lot has been previously disturbed and used as a stockpile area for the subdivision. The wetlands are located on the opposite side of Hancock Ct., the roadway has been installed and utilities are in so they are ready to build the house. Mr. Merrikin stated there will be no runoff into the wetland area, silt sacs shall be in place and filter socks along the edge of street preventing erosion into the drainage system. He has submitted revised plans due to Town Engineer comments dated 6/27/12 which extend the erosion controls. Another change made to the plan was making the snow fence optional. Mr. Merrikin stated the conservation agent can direct that should the silt sac be buried during construction, snow fence shall be put up.

Ms. Hershey stated she has nothing to add to the comments as this is a straightforward Determination

Mr. Goetz stated he has no problems with this activity and felt the Request for Determination was an appropriate filing

Mr. Wiley stated he felt a crushed stone apron should be in place at the access point during construction

Mr. Merrikin stated he has no problem with that. He stated Phase one (1) is to take out stockpiled materials that are there. He also stated the driveway location shown on the plan is the access point and a crushed apron can be put on the plan. Mr. Merrikin also stated street sweeping could be a condition.

Mr. Wiley asked if there were questions or comments from the audience.

Mr. Kevin Sullivan, owner of Hancock Ct. Ext. would like to know if there will be building on top of the stockpiled material

Mr. Merrikin stated the materials will be removed

Mr. Goetz made the motion to close the Public Meeting Ms. Dyer seconded the motion
