# **DISCUSSION**

#### **TURNER POND**

Mr. Philip Dubois, abutter was present during the discussion regarding Turner Pond.

The board continued a previous discussion from their last meeting regarding the request by the Ponds Committee to allow trolling motors on Turner Pond. Ms. Hershey stated she has heard back from Town Council, and gave the board members a copy of the email received on 7/10/13 with their input.

After discussion and review of Town Council's comments, the commission concluded they are not in favor of any power driven boats on Turner Pond.

Mr. Goetz made the motion to uphold the conservation commission regulation that motorized driven boats are not allowed on ponds which are under the jurisdiction of the conservation commission; this includes Turner Pond.

Mr. Adams seconded the motion Vote: 5-0-1 (Mr. Turner abstained)

Ms. Hershey discussed looking into allocating funds for surveying the easement at 12 Sexton Farm Rd. trail

# WETLANDS FILING ACCOUNT

Ms. Hershey stated the office is in need of a new laptop computer to be used at regular conservation commission meetings, as the Board Secretary has had to use a floater computer for the past several months. We are requesting to expend funds up to \$1,000 from the Wetlands Filing fund for this purchase

### SUNNYROCK FARM

The Board of Selectmen is requesting comments from Departments in regards to the first refusal under sec 61A of the Sunnyrock Farm property. The owner is required to notify the Board of Selectmen they are planning to sell. After discussion the board has voted:

### **BOARD COMMENTS**

# **Zoning Board of Appeals – 1900 Main St. (Zion Property)**

Ms. Hershey stated this hearing before the ZBA is in regards to the applicant requesting a permit to obtain a license for selling cars. She has gone on-site and spoken with the owner and person who will be leasing the property. The parking area which they are planning on paving has quite a bit of water accumulating in it and the owner has agreed to put haybales up. After discussion,

the commission's comments to the ZBA are that work will be done in the buffer zone so the owner needs to file with the conservation commission

#### ENFORCMENT ORDERS

Plimptonville Crossing – Ms. Hershey stated she is keeping an eye on the site and there are no issues at this time

South St. #400 – Ms. Hershey stated there is nothing to report at this time

West St. parking area – Ms. Hershey stated she is working with the owners on this

Industrial Rd. – Ms. Hershey stated that per the instruction of the commission she sent a letter to the owner and wrote fines of \$300 per day beginning on June 20, 2013, and delivered it by hand. An email was received following this by Mr. DiSangro who claimed he was waiting for additional information from the Town Engineer's office in order to complete the work required prior to filing his Notice of Intent. Mr. DiSangro has 21 days to either pay the fine or contest it. Since the letter was sent out, Mr. DiSangro has filed a complete Notice of Intent and is on the August agenda. The commission discussed modifying the \$1800 fine and split it in half if Mr. DiSangro agrees to give up his right to take this to court. A letter will be sent and phone call to Mr. DiSangro to see if this is something he will agree with as he has fulfilled the request of the commission and filed a Notice of intent.

Mr. Finnigan made the motion to reduce the fine to \$900 as long as Mr. DiSangro puts in writing he will give up his right to go to court

Mr. Adams seconded the motion
