NOTICE OF INTENT

BUBBLING BROOK RD. #44

Mr. Wiley read the advertisement from the Walpole Times. This hearing has been opened and continued from the last meeting.

Mr. John Glossa was present representing the applicant. He briefly explained some of the changes to the proposed activity for the Bubbling Brook Subdivision. Mr. Glossa discussed some of the changes include: the road width is now wider than before, the trees in the drainage basin area have been located and shown on the plan, a berm is to be added in the area of the basin and will be in the 25ft no disturbed if approved. The Headwall has been relocated down toward the basin, the water table is now shown, and new wetland flags are now depicted on the plan. Mr. Glossa stated, after review he would prefer not to relocate the basin to higher ground.

Ms. Hershey discussed the basin and asked how it was going to be designed. She stated the berm is located on only one side and the location of the basin might be misunderstood by future owners. Ms. Hershey suggested plaques showing the limit of work be depicted on the plan. Ms. Hershey stated the revisions discussed did not come into the office until today

Mr. Glossa stated that the Town Engineer and Ms. Hershey have not had the opportunity to review the new plans and see the changes.
