Council on Aging Board Meeting Minutes

Meeting Date: Thursday, February 23, 2023

The regular meeting of the Council on Aging Board was held on Thursday, February 23, 2023, at 10:00am at the Walpole Council of Aging with the following members present; Josette Burke, Mary Jones, Sandyha Malur, Janet Fasanello, Linda Winslow, Jim Pellegrine, Marcia St Louis, and JoAnne Mulligan. 10:00 AM: The Monthly Meeting was called to order by Josette Burke

- 1. Attendance was taken, and then the Pledge of Allegiance was recited.
- 2. Sandy Pellegrine on Memory Care and Living with Dementia
 - Overall Dementia is many diseases, not just one
 - a. Symptoms can impact a person's ability to think, recall, communicate and complete daily activities
 - b. Currently 47.5 million people live with a form of dementia
 - Causes
 - a. Alzheimer's the most common
 - b. Parkinson's Disease
 - c. Huntington's Disease
 - d. Vascular Dementia
 - e. Traumatic Brain Injury
 - What is normal
 - a. As we age, we "slow down" does not mean that we have dementia
 - b. In order for it to be Dementia, it has to affect two areas of your life: Memory, Communication and Language, Ability to Focus and Pay Attention, Reasoning and Judgment, Visual Perception (depth perception)
 - Signs and Symptoms
 - a. Repetitive questioning and storytelling
 - b. Odd or inappropriate behaviors
 - c. Forgetfulness of recent events (short term memory issues)
 - d. Repeated falls or loss of balance
 - e. Personality changes
 - f. Decline in planning and organization (not paying bills, dirty house, etc.)
 - g. Changes in diet/eating habits (huge weight loss or gain)
 - h. Changes in hygiene
 - i. Increased apathy
 - j. Changes in language abilities, including comprehension (finding the right word, using inappropriate words)
 - Impact
 - a. Communication
 - b. Recognition
 - c. Perception
 - d. Orientation
 - How to help or support a person with Dementia
 - a. Focus on their abilities, not what they can't do

- b. Maintain a healthy diet
- c. Minimize stress "join them in their reality", don't contradict
- d. Prioritize safety most important
 - 1. If they wander, put a big Stop sign on inside of exit doors
 - 2. Hardest thing to do is to take away their car keys
- e. Assist with recognition and orientation
- f. Find new ways to communicate
 - 1. Gestures and non-verbal communication
 - 2. Just guide them
- Caregivers
 - a. Keep other people "in the loop", you can't do it alone
 - b. If you start to notice symptoms, get in touch with their doctor there are medications that can slow the progression

3. Review of January Meeting Minutes

- There were no additions or corrections noted
- Janet motioned and Marcia seconded the motion to accept the January Minutes as is
- The vote was 6-0-1 to accept the January minutes with Sandyha abstaining as she was absent
- 4. Outreach Update Jillian Newman (slides were provided)
 - The total Outreach number for January was 449 to 270 unique individuals
 - a. The most common method remains by phone, but there were 112 in-person office visits
 - b. The most common referral method remains as "self
 - c. Jillian provided slides including a Pie Chart with the breakdown of categories of Outreach
 - 1. Medical Rides continues to be a big demand and there was a big jump over last month
 - Center is now limiting rides to one ride/week per person and to a maximum of a 10-mile radius
 - Center has started tracking requests they were unable to fulfill and the reason why
 - RSVP is working with the COA to take some of the rides, but they need to hire additional drivers
 - Another "feel good" story
 - a. There was a gentleman living on an upper floor of senior housing
 - b. He was very frail and unable to leave his unit as a result
 - c. A first floor unit finally became available, but he had only \$200 that he could spare for a mover
 - d. He called the COA, and Jillian called a contact of his at HESSCO to coordinate the move
 - e. HESSCO helped the man to pack
 - f. Society of St. Vincent de Paul paid for the movers
- 5. State of the Center Kerri McManama (slides were provided)
 - Check-ins
 - a. Check in count continues to increase there were 2,848 total check-ins in January
 - b. The Average Daily Attendance for January was 142
 - c. Kerri thinks it might be because of the mild weather
 - d. Check in by Age Group is now more accurate as the Center has eliminated all the incorrect DOBs
 - Other Updates
 - a. Finance Committee Budget Meeting was February 13th
 - b. Center is working on finding additional items/substitutions for Breakfast to cover school vacations and the summer when we won't receive the usual items

- c. Walpole Day is going to be May 13th Kerri is considering setting up a subcommittee to help the Center plan for coverage, etc.
- d. Many programs are full with waitlists through the end of February
 - On Wednesday February 9th there were 199 seniors at the Center with no special programing scheduled
 - Chair Yoga there are 20 people on the waiting list (Walpole residents), so a streaming option has been added (Zoom)

6. Finance Update – (Sandyha provided slides)

- Total spent in January was \$2,156.68 (Operating Budget)
 - a. Still on track for FY spending a total of \$19,496.80 of \$43,600.00 has been spent
- A total of \$1,769.99 of the Formula Grant was spent in January (does not include funds spent on salaries)
- Gifts
 - a. The Center received a total of \$1,725.00 in gifts in January
 - b. A total of \$1,474.29 was spent in January leaving a balance of \$19,109.08

8. New Business

- Walpole Housing Update
 - a. There were no meetings in February due to various reasons
 - b. Communication is somewhat better, but there are still issues
 - c. They now have a permanent resident Board Member resident of Diamond Pond
 - d. The last meeting was cancelled at the last minute with no notice including to resident
- Master Plan Update still on hold as the Committee is still waiting for the red-lined copy from the consultant
- Select Board Update
 - a. No Update as the Select Board Meeting was very brief due to the Legislative Breakfast
- Friends of Walpole Update
 - a. No Update as Rich did not attend today's meeting
- Legislative Breakfast
 - a. There are 4 Legislators: John Rogers precincts 1, 2, 6, 7; Ted Philips precincts 1, 2a, 3, 4, 5a; Marcus Vaughn precinct 5; and Paul McMurtry precinct 8
 - b. Held at Walpole High School this time instead of State House

- c. A decision had been made to go with 4 or 5 issues rather than a long list to present to the legislators
 - 1. Prison Walpole wants a "seat at the table" to be apprised of any decisions to be made. Walpole wants to ensure that there are no "backroom decisions" that they will not be aware of
 - 2. Tri-County
 - Currently there is a \$280 million price tag the State will only pay \$80 million, the same for a "regular" high school
 - There are 11 communities that are a part of Tri-County each community will pay the tuition based on the number of their students as usual, plus whatever the cost of the new building
 - A new school will carry a minimum of \$1 million price tag for Walpole
 - The 11 communities that are a part of Tri-County will be meeting in a week to prepare a plan
 - Currently October 24th has been set for a Yes/No Vote by the 11 communities to go forward with building a new school
 - i. The majority carries the vote no matter what
 - ii. The difference between the vote for Tri-County and Walpole's Charter any vote requires the prior knowledge of how much and for how long a term
 - 3. Kraft Train / MBTA
 - The MBTA is "talking" about possibly moving the platform down by Gilmore's to alleviate the safety issues currently at the station
 - No decisions have been made, and this is very much in the future
- Potential Board Candidates
 - a. The Executive Board will be meeting next week to choose a candidate and make their recommendation to the Select Board
- Topics for Future Meetings:

 - b. April: Brendan Croak of the Recreation Department

 - d. June: Elections; also "Deep Dive" of this past year, and any topics, etc. for next year
