The meeting was called to order by Dennis Crowley at 7:00pm.

Finance Committee Public Hearing

(0:30) Motion by Mark Trudell and seconded by Douglas Shea to open the Public Hearing. The motion passed 12-0-0.

Precinct 3 RTM and Chair of the Walpole Historical Commission Jennifer Karnakis asked if the Massachusetts Historical Commission has been notified about Article 18 and the potential for the Old Town Hall to be sold.

Jim Johnson stated that the Massachusetts Historical Commission participated in the 2019 study, and the information has been made public about this article for months. He has not heard any complaints from the Massachusetts Historical Commission regarding this article.

Jennifer Karnakis stated that the article has not been made public enough to the Walpole community. Dennis Crowley stated that the Finance Committee unanimously voted favorable action on this article, not necessarily because they are all in favor of selling it, but rather because they are in favor of bringing the issue to Town meeting for a discussion.

Jim Johnson stated that the Town has done several professional studies over the years about the Old Town Hall, and they all come back recommending its sale. They've tried and failed to get grant funding to maintain the Old Town Hall, and upkeep is becoming increasingly expensive.

Mark Trudell asked if the Select Board would have to go back to Town Meeting for approval if the sale price exceeds a certain threshold. Jim Johnson stated that the authorization would be universal.

(10:27) Motion by Mark Trudell and seconded by Kathleen Foley Greulich to close the Public Hearing. The motion passed 12-0-0.

Jim Johnson stated that there would be a Finance Committee Meeting on Wednesday, May 3rd to vote for an authorization to allow budget transfers of up to \$10,000 after Town Meeting.
