- Construction bids will be submitted in the Fall of 2016





for the February 2017 Grant deadline






Council On Aging – proposed floor layout

Walpole Fire Station

- \$900,000 appropriated in the Spring of 2015 for Project Management & Design Services and \$1,369,067 was appropriated in the Spring of 2016 for the construction of this project.
- Design development will be completed in the next month.
- Construction bids should be submitted prior to the Fall Town Meeting. Once bids are in hand Town Meeting will be asked to consider a request to fund the construction of a new Station without the need for an override.
- The Town is proceeding forward with locating Temporary Operations during construction for WFD in front of Blackburn Hall.









Fire Department—proposed floor layout



Fire Station – Conceptual exterior layout




Fire Station – Completed Parking layout


South St. status update

- All buildings have been demolished. The areas outside of the building footprints have been cleaned & the EPA has approved of the work completed.
- After building demolition the soils under concrete slabs were tested. Some of the slabs were found to contain contaminants.
- The EPA required the Responsible Parties to develop a cleanup plan and schedule for the concrete slabs. The plan has been submitted to the EPA for their review and approval.
- It is expected that clean up on the East side of the site will begin in July. The Responsible parties will come in to perform soil remediation in the Fall once the Slabs are out and the then the EPA will have 45 days to process the necessary paperwork related to the post closure of the site.



South St. status update

It is expected that work on the West Side of the property will be completed in the Summer/Fall of 2017. This side of the site will serve as a treatment facility and a parking lot for overflow parking.
