She asked have you ever had a problem. Mr. Xeng no we check id with machine. The best way is to scan ID. Mr. Gallivan explained we have had a lot of trouble in the past at this location, and we hope you are successful, keep an eye on underage drinking. We suggest that you put it out there that it is under new ownership. Let people know that there are new owners and run better.

# 6-29 Request of Corcoran to relocate sidewalk in front of their project "The Commons at Walpole Station"

Mr. Johnson reported his request came forward a few months ago. We met on site, I would prefer to not have to move people from one side to another. It is a solar crosswalk sign.

Abigail Middleton representing Corcoran and Company explained they are looking for a temporary sidewalk. We have updated the plans, found a route on our side. From June of this year until next June. It is for the safety or pedestrians. Showed the plan, West St. is a primary route for pedestrians. It will be a five-foot temporary sidewalk with concrete barriers. It will be ADA and we will remove the snow. All traffic signage. Try everything to keep traffic flowing and keep everyone safe. Paint new lines.

Mr. O'Neil questioned how wide will the sidewalk be. Abigail stated it is five feet. We have a site contractor on site. Will engineering be out there? Ms. Middleton stated that across the street is a parking lot. We want to keep people crossing safely. We will put in the compliance signage. The traffic lanes will remain 11 feet.

Mr. O'Neil wanted to know what would happen when the project is finished and take the fencing down. Ms. Middleton stated they are building the new sidewalk. We will put in new curbs and restripe the street.

Ms. Walker is comfortable with this. Chris Johnson met with the police and other departments and they were happy with this. Mrs. Mackenzie wanted to know if on the opposite side of the Street are they redoing all the curb cuts?

Mr. Johnson explained the town was approached by Mr. Duggan and he wanted to purchased it. All 3 parcels. He wants to expand. Ms. Ragosta is this required to go out so other buyers could buy this land. Mr. Johnson stated yes.

#### 6-31 Fighting the Opioid Epidemic

Mr. Johnson explained this is a national case that K&P that is working with other firms. To enter into this litigation a no extra cost to the town. They are going after the pharmaceutical manufacturers and distributors for their role in the devastating opioid epidemic, which has resulted in massive economic damages to Massachusetts's cities and towns.

MOTION moved by Mrs. Mackenzie to authorize The Town Administrator to execute the agreement for Legal services for engagement of the National firms in the Opioid litigation seconded by Mr. O'Neil VOTED 3-0-2 (Mr. Salvatore and Mrs. Mackenzie abstained)

## 6-32 Request to use Wetlands protection Act Fees

Mr. Johnson explained last year we did this, this covers Landis time and some of the secretary's time. Jack Wiley, Chairman of the Conservation Commission explained the last time we asked for money was August 2016. We are requesting \$10,000, approved at the last Conservation Commission meeting, to help balance the budget. This is the state fee that goes toward the town. Explained how the fee works. This money is used to supplement our agent and secretary beyond activity that is budgeted, administer the Wetlands protect act. Landis works on the Open Space plan, the MS4 plan, trail at memorial pond. Attending other meetings. The money is for anything over the 29 hours a week.

Ms. Ragosta these funds that are being requested are outside the regular budget process. That concerns me. Concerned about that it is above what has been appropriated. Mr. Wiley the secretary's time at meetings comes out of this fund. She is shared with the Zoning Board. The best way to handle the meetings are to pay her hours out of this fund. Ms. Ragosta has that been an ongoing process. Mr. Johnson stated this has been going on since 2000. Ms. Ragosta feels the dept. budget should go through the right budget. Mr. Johnson explained these funds do not allow that, we reduce the budget accordingly.

Mr. Wiley explained that in accordance with MGL the fees go into these funds and cannot be mingled with the budget. The fringe benefits are not included with these hours. Mr. Johnson explained that her personal time and vacation time are not part of that calculation. Ms. Hershey, Conservation Agent stated if there was a week were I worked over my 29 hours, I don't get benefits over those hours. Ms. Ragosta with respect to the Secretary piece. When the secretary is budgeted at town meeting, these extra hours are not. It is the same hourly rate. Yes it is .

Mr. O'Neil great job you guys do. Is this request come and go or is it flat? Mr. Wiley it seems to work out every two years. Mr. O'Neil so next year you may not need the money. Every year we use some of the money. There is a part of me that says if it takes extra hours, why don't we just fund it. Do it so we do not have to do this year after year. Mr. Wiley these funds can only be used for specific purposes. Mrs. Mackenzie wanted to know can you use those funds to update conservation plan. To be used to protect the wetlands. Ms. Hershey explained it is a fund that was set up to help conservation to help pay staff. Mrs. Mackenzie wanted to know if would you be able to hire a consultant. Landis replied no, just for in house staff.

MOTION moved by Mrs. Mackenzie to approve the request of Conservation Commission to expend \$10,000 from Wetland Protection Act Fees Account for staff purposes in administering and enforcement of Mass Wetlands Protection Act seconded by Mr. O'Neil, VOTED 5-0-0

Ms. Hershey says that they do need more hours. They seek additional hours every year.

#### **OPEN FORUM**

Liz Barrows I was recently elected as an RTM, I submitted an application to be on the Housing Partnership Committee. The BOS can increase to 11 if deemed necessary. Mr. Gallivan I asked Cindy to hold that. He wanted to ask the Chair of the Committee. We did the same thing with the COA and it was not a good thing. I am the reason it is on hold. We hope to hear back from them. In the event that the Chairman doesn't want to add anyone what will you do. We will have a conversation.

Jimmy Taylor- Why are streets being tarred that do not need to be tarred. Mr. Gallivan you can ask the question, but I cannot answer. Mr. Johnson is aware that he visited the DPW. I visited with them and there is a pothole. We do have a pavement management plan. Industrial road across from Chris Service there is a pole that needs to be fixed.

- 3. Water Dept. Pipe replacement –Attached a list of streets that will have their water line replaced this year. Bids will be opened on Wednesday July 11<sup>th</sup> for late summer/fall construction.
- 4. Keep Walpole Beautiful committee-met with them last week, I explained to them they would be bound by open meeting law. If you like to have this placed on an agenda let me know. They came up with the mission statement. Mr. Salvatore approach the Chamber of Commerce we could discuss that instead of being a town committee. I did see some of the things they did and they cleaned out the CVS parking lot. Do we have a procedure that we will get rid of the disposal?

Mrs. Mackenzie before they come to us, maybe they can sit down with Cindy and make sure that we line them up with other committees. Run by Bob at the DPW. Questions about setting up this committee. Robin and Cindy could meet with them. Mr. O'Neil I like this idea a lot. I would love to have them come in.

Ms. Ragosta does have a concern about the mission statement. I do not want this committee to overstep and have us be the litter police. Language matters. If we adopt this, that is a very broad based. The public private relationship. They are not in a position for us to create new laws.

Mrs. Mackenzie does have a few worries, technical worries, even before we put them on the Agenda. Look at it. Thinking about them at CVS. What is our ability to go onto private land. Before it is on the agenda there is some work that needs to be done. Mr. Gallivan supportive of the idea
