The Select Board met on Tuesday, November 23, 2021 beginning at 6:00pm in the Finance Committee Room of Town Hall and at 7pm moving to the Main Meeting Room. The following members were present:

Appointments

Call to Order and Pledge of Allegiance

Chair Gallivan called the meeting to order at 6pm followed by the Pledge of Allegiance.

Hilltop Securities, Discussion, and Vote on Middle School Project Borrowing Options

Town Administrator James Johnson announced that because borrowing rates are at historic lows, the main question was whether to borrow \$50 million now or borrow \$20 million now and the rest later. Peter Frazier of Hilltop Securities informed the Select Board of the risks involved in borrowing large sums of money and advised that 85% of the sum should be spent within three years. Vice Chair Barrett stated that in either scenario, spending 85% of the borrowed money within three years should not be difficult. Clerk Maffei asked about the drawbacks of holding on to unspent borrowed money for multiple years. Board member O'Neill expressed concerns about the possibility of borrowing rates going down and being locked into an agreement at the higher rate. Mr. Frazier stated that rates may continue to decrease in the short-term, but in the long-term they will almost certainly increase. Mark Trudell, Chair of the Finance Committee recommended going ahead with the \$50 million now. Chair Gallivan clarified that in the unlikely event that the middle school project is cancelled, the already borrowed money can be allocated to another project. Nancy Gallivan asked what other towns in similar situations have done, and Mr. Frazier stated that many have borrowed larger sums to take advantage of the lower rates. Brian Jarvis of Compass Project explained the project's estimated timeline to the Select Board. Vice Chair Barrett asked if there are any items that may delay the project, and Mr. Jarvis stated that problems with the electrical equipment would pose the greatest risk of delay. Board member O'Neill stated that this was a good discussion that involved a number of very qualified people -- Select Board, Finance Committee, Hilltop, School Building Committee and School Committee. As a group we have discussed several risks including the direction of interest rates (up, down, staying the same) in the near term and over the longer term, and project risk -- what happens if the project does not get completed? We acknowledge these risks and have properly debated the various scenarios. After all of this discussion, it is reasonable to believe that interest rates will go up over time and that it is in the town's interest to borrow a higher amount to avoid higher interest expense in

the future. On motion of Chair Gallivan, seconded by Board member O'Neill, voted to direct the Town Administrator, the Treasurer / Collector, and the Finance Director to move forward with a \$50 million borrowing plus anything else you want to add for other things that we agreed to at Town Meeting to borrow in the January/February 2022 timeframe. On roll call vote of the Board, Motion Passed (5-0-0). On motion of Chair Gallivan, seconded by Board member Mackenzie, voted to approve the MSBA Middle School Project Funding Agreement and authorize the Town Administrator to sign on the Board's behalf. Motion Passed (5-0-0).

Recess - Relocate to Main Meeting Room and Reconvene Meeting

On motion of Board member Mackenzie, seconded by Chair Gallivan, voted to recess and reconvene the Select Board meeting in the Main Meeting Room of Town Hall at 7:05pm. Motion Passed (5-0-0).

Clerk Maffei introduced Troop 44 Life Scout Ian Jacob to the Board and explained how Ian is looking to get more involved within the Town and government. Ian introduced himself to the Board and provided some background on the merit badge he is currently working towards. The Board thanked Ian for being here tonight.

Public Hearing for Tax Classification for Determination of Residential Factor for tax rate for fiscal year 2022 On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to open the Tax Classification Public Hearing. Motion Passed (5-0-0). Board of Assessors Chair John Fisher was present. John provided an overview of the process taking place tonight and highlighted certain pages of the comprehensive report provided to the Board that referenced the Shift, Levy Limit, New Growth and Scenarios for FY2022. The Board thanks the Board of Assessors for the informative packet as always, Chair Gallivan noted that the Board of Assessors did not however take a vote at their last meeting to provide a recommendation to the Select Board. Chair Gallivan commented on a letter received from the Economic Development Commission asking the Select Board to maintain the current shift.

Public comment was provided by Richard Zaccaro, speaking as a Walpole resident and taxpayer. Mr. Zaccaro advocated to the Select Board for a shift of 1.35. Public Comment was also provided by John Fisher as a resident. Mr. Fisher endorsed keeping the shift the same as it is presently especially looking to the future and the impact of the override for the middle school project. Public comment was also provided by resident Linda Coletti in relation to the impact on seniors in the community.

A lengthy discussion occurred amongst the Select Board members; weighing up all the information provided to them. On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to close Public Hearing. Motion Passed (5-0-0).

On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to adopt a shift of 1.275 with a residential factor of .9593 for fiscal year 2022. Motion Passed (5-0-0).

On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to authorize the Town Administrator to submit the results of this hearing on behalf of the Select Board to the Massachusetts Division of Local Services Gateway System. Motion Passed (5-0-0).

Carl Balduf, Town Engineer seeking Vote from the Board for Taking and Acceptance Documents for Emerald Way and Olmsted Lane

Carl Balduf was present and outlined to the Board that this was the final step in making these roads public.

On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to accept the rights and easements related to Emerald Way (Portion) and Olmstead Lane and sign the acceptance documents. Motion Passed (5-0-0). On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to take the public rights in Emerald Way (Portion) and sign the Order of taking documents. Motion Passed (5-0-0). On motion of Board member Mackenzie, seconded by Board member O'Neil, voted to take the public rights in Olmsted Lane and sign the Order of taking documents. Motion Passed (5-0-0).
