A regular meeting of the Board of Sewer & Water Commissioners was held on Monday, May 23, 2011, at 7:00 p.m., at the Edward J. Delaney Water Treatment Plant, 1303 Washington St.

Present: John Spillane, Roger Turner, Patrick Fasanello, Kevin Muti and Ken Fettig. Also, Rick Mattson, Supt. of Sewer and Water; and Scott Gustafson, Asst. Supt. of Sewer and Water.

All abatements submitted tonight are reviewed and signed.

Motion Made by John Spillane to accept the minutes of May 9, 2011. Second by Patrick Fasanello. Vote 2-0-2, Muti and Turner abstained.

SUPERINTENDENT'S STATUS REPORT

Mr. Mattson says there is not a lot to report. The date for the site visit to Somerset for the pre stressed concrete tank has been rescheduled to June 1.

REQUEST FOR COMMENTS – 68 POLLEY LA, RDA

This is before the Conservation Commission for a septic system and is read and noted with no comments necessary.

REQUEST FOR COMMENTS – 2050 MAIN ST, RDA

This is before the Conservation Commission for a septic system and is read and noted with no comments necessary.

REQUEST FOR COMMENTS –7 WOODRUFF RD, RDA

IRRIGATION REQUEST – 133 ENDEAN DRIVE, SUREKA

Motion Made by John Spillane to approve the request for the irrigation system at this address provided all the requirements of the Superintendent are met and they adhere to the Water Management Policy. Second by Roger Turner. Vote 5-0-0.

YOP TEC ASSOCIATES

Mr. Mattson says this is done annually and they are very cautious in sensitive areas but our usual form letter will be sent. Mr. Fasanello notes that their report states that they will be using hydrants and Mr. Mattson says he has never known them to use our hydrants. **Motion Made** by Patrick Fasanello to

include in the letter that the Sewer & Water Commission must be notified if they intend to use our hydrants and that they must have a backflow device and one of our meters prior to any usage. Second by Ken Fettig. Vote 5-0-0.

MCDONALD'S CORPORATION SITE PLAN DECISION

Mr. Mattson explains that the current McDonald's on Main Street is being knocked down and rebuilt. The only effect with regard to water and sewer is the sewer line will be coming out the front instead of the rear. Also they will be installing an underground grease interceptor.

There is discussion on grease trap inspections and Mr. Fasanello says he knows someone who could train for inspections. Mr. Mattson says we used to have a program in place and will pull the files.

Motion Made by Ken Fettig to have Commissioner Fasanello set up a program for inspecting grease traps. Second by Kevin Muti. Vote 5-0-0.

SUPERINTENDENT'S BID RECOMMENDATION – HIGH LIFT PUMP EQUIPMENT

Mr. Mattson explains that this is his recommendation of award for bids taken for removal and inspection of the high lift pumping equipment at the E.J. Delaney Water Treatment Plant. **Motion Made** by Roger Turner to concur with the recommendation of the Superintendent in awarding this bid to Maher Services Inc. in the amount of \$32,000. Second by Ken Fettig. Vote 5-0-0.

RECREATION ABATEMENT REQUEST RE-SUBMITTAL

This was on the last agenda and it was asked to be put back on to see if any of the Commissioners that were not present were interested in abating this \$8476.23 bill for the town pools that are in arrears for water charges. The Commission is told that there is another \$9900.00 water bill outstanding for watering the Stone Field last year. There is discussion. **Motion Made** by Patrick Fasanello not to abate the water bill for the pools. Second by John Spillane. Vote 5-0-0.

Motion Made by John Spillane to adjourn. Second by Roger Turner. Vote 5-0-0. Meeting adjourned at 7:25. p.m.
