He further explains that the options will change based on reports of the Environmental Assessment etc. Mr. Pilla says this is an ongoing process and we need to begin complying each members thoughts and documenting them.

# **USE #1 - Municipal Building - Town Offices**

# Roger Turner

- •Current Town Hall has a space issue for meetings and storage
- Possibly use Old Town Hall for offices for the various smaller committees

- Emergency Management is in need of space for supplies
- If used for municipal space it may become an economical burden

#### Christine Cochrane

- Against being used for municipal space
- Fears it would sit as is with no renovations done
- Would like to see more citizens given access to the building to enjoy

#### Sam Obar

- Against municipal use
- Town does not need an excuse to have more offices and employees

#### Marc Romeo

- Municipal should be the last resort use
- It would be the "Walpole Thing" to do but would hate to see that happen

#### Mark Trudell

• Building Commissioner and DPW agreed this would be the lowest initial cost use but in the long run it would not generate anything positive

#### Cliff Barnes

• Against municipal use - it would be another building to have an impact on the tax rate

#### Richard Pilla

- The objection is to have this building be the catalyst for opportunities to bring business downtown
- If municipal use it would be closed nights, weekends and holidays want it open

# USE #2 - Performance & Cultural Center - Town Owned & Operated

#### Cliff Barnes

- Do not feel the town should own but should be privately owned and operated Leaning this way but could be convinced otherwise
- If the town continues to own this the town will have to pay for the repair and updates required and it will be very expensive
- Would like to see a Performance Arts Center
- Would listen to leasing options viable for long term

#### Mark Trudell

- Selling the building would provide a short term influx of cash
- Lease terms would offer a potential stream of revenue long term for the town
- Lease deal would be a better option for the town
- Would like to see a Performance Center with incorporating the cultural aspects with the Civil War Plaques and the original jail cells

#### Marc Romeo

- The ability to have functions and performances in an Art Center is key to increase revenue
- A function space needs to be a part of this reuse
- Town should retain ownership do not want the town to lose control of what happens in the Old Town Hall
- Town should never be involved in the operational day to day business
- Form a Non-Profit Committee to oversee
- New 500 market rate apartments are being built in downtown Walpole over the next two years Built in audience is on the way

#### Sam Obar

• Agrees the town should not manage the facility on a day to day basis

# Roger Turner

• Concerned with the restricted size of the performance area due to the location of the current elevator and bathrooms

#### Christine Cochrane

- Feels a Performance/Function use would be best
- Town keep ownership with a long term lease
- Concerned if a group exists that will provide such a large amount of cash and commitment

# Richard Pilla

- Performance vs Cultural can have both Rotating displays
- Preserve but make more economically feasible by expanding the current building with additional clean space Still preserving the historical aspects Add an additional 1500 sqft
- Would like to conduct a Demographics survey

#### Roger Turner

- Cautions needing to check on the deed restrictions already in place
- Questions how would the town handle a possible bankruptcy
