Mr. Johnson spoke to being very pleased to present this to the Board. We are pleased with rates about 3%. Disappointed we could not increase to AAA bond rating.

Marilyn Thompson, Finance Director explained the \$200,000.00 are for road improvements and the Bond in the amount of \$19,627,000.000 is for Police Station, Fire Station, roof and window replacements, water main replacements and water booster pump station. The town received two bids on the BAN resulting in an interest rate of 1.30% and received 5 bids on the bonds resulting in an interest rate is 3.01%. The town is at an AA+ rating.

TOWN ADMINISTRATOR UPDATE

Finance Committee- the Committee will likely meet on Thursday night to consider any final matters that need to be considered before the public hearing on April 27.

Moose Hill Road 40B- The Company that is purchasing this development will be holding a public outreach session on April 24, 2017 at 7pm in the library.

East Walpole Washington St Bridge-He met last week with the Engineer who explained this bridge was in urgent need of repair/replacement. The estimated cost for this work is about \$8.5 million. We are trying to explore options with the state to determine if there are any funding sources available.

Fire Department building update- we are planning for the groundbreaking on Thursday at 5:30pm.

Expect the bids for the Council on Aging facility in June. We want to get a general idea of what the cost is to construct this building. Mr. Kraus inquired if we know where the Friends are with their fundraising. Mr. Johnson has tried to reach out with no success.

4-3 Eversource petition, install overhead transmission lines

MOTION moved by Mr. Salvatore to open the hearing seconded by Mr. Gallivan VOTED 4-0-0

The representative from Eversource explained they were here before the Board two years ago this is for an 115V transmission line; we are here to talk about the section within Walpole. Some of these lines will cross over Washington and South Street. It is not going to cross over Pine Street.

Mike Sutton VHB explained the project does cover the MBTA line. That will require a permit thru the MBTA and crosses RT1A. We did go before Conservation Commission in 2015 and received our approval. This process began with the DPU in 2016. We filed the certificate, Army Corp of Engineers permits, and Mass Historical has been acquired.

There was discussion as to whether or not this was an upgrade or additional power. This project was required by SF New England, which did a study and came out with over 40 projects that needed to be addressed. On the existing ROW, there are two circuits on one pole, From station 146 on South St, to station 447 off Main St, we will have to install monopoles as we have no space in that area. For future growth in the same area, they will always be on.

Mrs. Mackenzie inquired about the clean up on the curve. The town wants the street to look good and she believes that when they were before the Board two years ago it was implied that you would make it look better. Jack, from Eversource state they are not addressing that issue. They cannot do it until this is approved.

4-4 Eastern Pearl Hearing

NOTIFICATION

*** Letters were sent to the establishment by Certified and Regular mail on January 20, 2017, February 22, 2017, March 21, 2017 and March 22, 2017. The hearing was originally scheduled for February 28, 2017 but at the request of Eastern Pearl's attorney the Board agreed to reschedule the hearing until March 14th. At the request of the attorney for Eastern Pearl the hearing was again continued to April 11, 2017.

CONDUCT OF THE HEARING

MOTION moved by Mr. Kraus to open the hearing for alleged license violation of the terms of their liquor license for Hong Kong Eastern Pearl Enterprise Inc. d/b/a Eastern Pearl, 2275 Providence Hwy, Walpole, MA, seconded by Mrs. Mackenzie VOTED 4-0-0

Attorney Jeff Blake explained he spoke to the Attorney and he does not believe that his client can fully understand this process. He indicated to me that if you want to wait for a translator.

Mr. Kraus noted the Board has agreed to postpone and postpone, and he is not in favor in waiting for interpreter. Mr. Salvatore noted the town is paying the police to be here, my recollection, he indicated that he understood what is going on and now at the last minute he doesn't. Counsel should have provided us with this information before this. Counsel was away at the last hearing date and it is very frustrating, I do not know the rule, if he is represented by Counsel.

It was questioned by Mrs. Mackenzie if they can we use a phone interpreter service. Attorney Blake does not recommend and he agrees with your frustration, Counsel had an issue not of his on doing. The applicant should provide an interpreter. It is a corporation represented by Counsel.

Attorney Blake, I share your frustration, even if it is a corporation, if Counsel is telling me that they do not understand the issue before him. I share your frustration, at the 12th hour to have this come up, he has agreed to bring a translator, there is a situation, that his client does not understand.

Chief Carmichael we have officers here and they have spoken to the owner, to now come to the Board and throw this on us now. There has been communication back and forth, I find it disturbing.

Mr. Kraus if we go forward will it hinder to our ability to take action? Attorney Blake noted it will

make it difficult.

Attorney Wei Jai, I thank you for rescheduling the hearing, on March 14th my father past away and spent ten days over there, there was a lot of stuff on my desk. We talked about hiring a court translator, but I was not able to get him here tonight.

Mr. Kraus expressed sympathy for his loss but finds it troubling, that what seems to be gamesmanship seem to be played now.

Attorney Blake will it cause a legal problem? I can not give you an answer, the fact that the person being charged is unable to testify on his own behalf. It is way late in the game. They are saying he cannot participate in this. He has had notice; the opportunity to be heard is in question.

Attorney I have an alternative, the 3 events, offer a solution to avoid the dilemma. Mr. Kraus the dilemma is not having a translator. Mrs. Mackenzie wanted to know if they are listening to testimony. Attorney Blake suggested listening to what he has to say.

Attorney Jai the events are 1/12/17, 1/29/17, 2/23/17 the January 12th event we were before the clerk magistrate, there is a gap, Mr. Zhang is not ready to admit to the facts, the January 29th event he was not aware of the car crash that happened somewhere were someone said they had a drink at Eastern Pearl. The February 23rd, event where five young people came to the bar and in the past he checked their ID. They are known to him. Two underage customer, they came to my restaurant last Dec, both showed me their ID over 21, one told him he just past the 22 birthday so he gave him a birthday drink. Now he realizes the two underage people showed him were fake. He should be able to notice the fake ID. So for that he should be penalized.

Mr. Kraus, so you are offering two weeks for the February 23, 2017 event. Mr. Salvatore noted we have a progressive, he is admitting to the 3rd event. Attorney Blake you have discretion, you can make a case that there were two other events. I think there are circumstances that you could take into account.

Mr. Kraus if we look at these as individuals, if any of the two proceedings and they are found guilty I want to revoke the license. It was noted by Mrs. Mackenzie if he cannot understand the language and unable to communicate with us maybe he should not be open. Discussion as to what would happen to the other two charges. If a year from now, he gets convicted If he is found guilty the Board can go back. Or are you saying he agrees to the February 23 and we are done with it.

Attorney Blake explained if you want to move forward with the other events we would need a translator. He agrees with February 23 but not January 12 and 29th. If he is found guilty the Board can hold another hearing.

It was Mr. Salvatore's position the February 23 incident rises to more than a two week penalty. Attorney Jai those facts have not been established. They are allegations. Attorney Blake explained they are not bound by hearsay rules, the court is. To take them out of order, may not be a finding of guilt, I don't see that as a problem.

Mrs. Mackenzie so we can wait for a translator and take up all three issues. If we take the two weeks now we can give him another warning.

Mr. Kraus asked the Police Chief, you have been involved in this what would your recommendation be? Police Chief Carmichael stated we are dealing with enough problems, to think that kids can go into a bar in town and get intoxicated. Hate to loose on appeal to the ABCC. I would wait for you

to continue it and get a translator.
