12-13 Memorandum of Agreement Walpole Woodworkers Development

Mr. Johnson presented the Board with the agreement with Pulte to develop 186 units for an age qualified development. He is happy with the agreement. Basically everyone is getting what they asked for. Ms. Ragosta is glad that they were able to use this location. It is near Blessed Sacrament, pleased that our older residents have stock when they downsize. Mr. Gallivan likes the idea it is a condo. He thinks this is a real win for the people of Walpole. Discussion on how are they going to address traffic, and it was noted the Planning Board will address that in the Planning process. The town will do a pear review and will address what is needed. The location is between the most dangerous intersections. It was noted the concern is Eastover as it is right across the Street. That might create the need for a traffic light. It was discussed. The on-site sewer pump station will probably be owned by the S&W Commission as they have signed off on it. The Board talked about the gift in the agreement. Because this is age qualified, some would like to see that the \$100,000 gets applied to the senior center. Ms. Ragosta does not see any impact on the fields or Fire dept. Mr. Kraus does not agree with fire, you have people that live there that will need public safety support. Mrs. Mackenzie agreed they will be drawing from the Fire dept. Ms. Ragosta feels the only impact from fire to her is the ambulance and we charge for that Mr. Gallivan is involved in fundraising, and is comfortable, the way it is, the money is not coming in one big chunk as our needs may change. It will come before this Board at some point,

Mr. Salvatore likes this agreement and a step forward, the money will come into the general fund and then used where it is needed. Pulte was given the option to give a direct gift to any one of these. One agreement was very specific and he likes this one as it is broader. Mr. Kraus would like to see the majority for COA 51% and we could make that an addendum. Ms. Ragosta does not think it should go to recreational fields. Guide it to one or two of these. Mr. Gallivan would like to see

the fields stay there, there will be walking paths. He likes the whole idea of passive recreation. The vast majority of the impact on the town is going to be the senior center.

MOTION moved by Mrs. Mackenzie to enter into a Memorandum of Agreement between Pulte Homes of New England LLC (Pulte) and the Town of Walpole, regarding the proposed redevelopment of all or a portion of property located off of East Street to develop and operate or convey an over 55 residential facility at or near all or a portion of the site known as Walpole Woodworkers and authorize the Town Administrator to sign on the Board's behalf to note the changes the majority of the gift will go to COA or Fire, but still leave fields in there, Seconded by Mr. Gallivan, VOTED 5-0-0

Louis Reed Pulte homes, we did want to add we are sympathetic to that. We are very positive and hopeful for, create a new senior housing. Thank the Board for your cooperation and staff. Thanked all the department heads as they appreciated their input. The Board suggested the more open you can be with the abutters as you progress will go along way, more transparent. Anything they can help with the process they will.

OPEN FORUM- Richard McCarthy, chairman of the COA. We had a senior luncheon and your board showed up in force, the seniors had a great time, very emotional and you really cared about the seniors. This is what I can envision when the new facility is open. Want to thank the Board, police department and everyone that volunteered.

OLD BUSINESS

Supa Sales- Mr. Johnson informed the Board that at their request he reached out to Attorney Volkin. We came up with this agreement and if they violate any of the conditions they would give up their license and not appeal. It is up to you. The Board had a lively discussion on this at the last meeting. Upon conversation, Mr. Kraus thought we are all pro-business and we do not want to hinder someone making a living in the town. If they agree to XYZ we can take another look at their permit, I felt good about that. This week they still have an A-Frame outside saying they do collision repair. I am at a loss with this.

Ms. Ragosta did see the email where they had a sign. I don't believe that is evidence. Maybe we should have surprise inspections. If we did a spot inspection and there is a violation can we pull their permit? Mr. Johnson will add something in the agreement stipulating that. She is willing to giving them a chance. It was discussed what happens that during this period the violations continue, there should be some recourse. In the event they do not meet certain milestones the Board can take their license. Ms. Ragosta this is a conditional license. Mr. Salvatore felt that pro-business means to me gets treated equally. We are not pro-business when we allow some to not follow the rules. Same rules for everybody, the way you get the same rules is you have rules and process. It is not fair to the other businesses. Mrs. Mackenzie noted they do not have a working septic system, the two boats and all the other cars. My vote is not changing.

Discussion- Mr. Gallivan likes the agreement I think it is a high bar for them to meet. I am in favor of this.

TOWN ADMINISTRATORS UPDATE

The Town Administrator of Medfield asked if we would be interested in a joint Veteran's Agent. They have only two residents that receive benefits. They will pay for a 1/3 of his salary. I would like to move forward with this agreement.

Mr. Kraus wanted to know how this is going to work, if Jon Cogan is working for both. Jon feels that he can handle the workload. I would not be looking to add more staff. Board wanted to know how the compensation would work. It was explained that initially we will pay his salary and they will have to pay 1/3 of the salary, the workload is less than our town. It would have to be an annual agreement as they may gain Veterans. I asked K&P to draft something and then you can consider it in January. Mr. Gallivan likes the concept, give it a try, I like a one year agreement. Mr. Salvatore thinks they can also look at some other part time position that we can share with other municipalities. I say explore it, a few of us should meet with the VA. Mrs. Mackenzie thinks that it is great for Walpole he has been helping out there.

He thinks it is ok as far as Walpole goes and we will be getting 1/3 of salary back. They are basically leasing our VA. Six months in we get an update and then at the nine month mark we can determine if we wish to do it again. The state requires the town to have an MOU with Medfield.

Community Development Director- the last time we had an updated design planner. I need to get going on recruiting someone on this. I think job title is job title but I need someone there doing the work. Laying out to you and Nancy and I can continue to work on this. We need someone up there helping. Mr. Kraus the question is what is the need. If we call it a planner or something else is irrelevant. Ms. Ragosta for Job description it is just a title. Is it a matter of the job requirements? This requires certification. This position works for the land use Boards. Mrs. Mackenzie thinks they have to be pushed together. There are things in both job descriptions and she likes Land Use Coordinator. That is planning. Make the new job description. She has had a lot of feedback. When we switched it over we knew we would have to come back to this.

Mr. Johnson can modify and strike the Community Development out of the salary schedule and call it Land Use Coordinator. Mr. Salvatore feels they need someone with a strong background in planning we have had disasters at T. Mtg over the past years. Review the code in its entirety and where we are going forward, the downtown is going to change in the next few months. Need someone with a strong direction, this is a fine opportunity.

Mrs. Mackenzie felt it would be very helpful when decisions are being written. We want to get these all into a data base. I am thinking the word Town Planner may give it more power. Town Planner and Community Development Director.
