FINANCE COMMITTEE

MINUTES

April 28, 2016

Regular meeting of the Finance Committee was held on Thursday, April 28, 2016 in Room #112, Town Hall with the following members present: D. Bruce, J. Denneen, J. Burke, R. Mariani, M. Trudell, J. McDermott, J. Vaillancourt, S. Lawson and T. Bowen. Members absent were: D. Crowley, K. Guyette, A. Healy, J. Lowre, P. Hinton and P. Stasiukevicius. Also in attendance was Town Administrator J. Johnson, Assistant Town Administrator T. Gregory, Finance Director M. Thompson, Town Accountant J. Cuneo, Recreation Director P. Shield, Fire Chief T. Bailey and Deputy Police Chief C. Michenzie.

Reserve Fund Transfers

Balance in Reserve Fund is \$230,000.

Veterans Benefits

Town Administrator J. Johnson spoke to this request. \$12,000 being requested. There was insufficient amount budgeted in the line item for Veterans Benefits. Amount budgeted was \$65,000, current balance is \$5,688. Town receives 75% reimbursement from the State for these funds which goes into the General Fund.

Elections

Town Administrator J. Johsnon spoke to this request. \$59,000 being requested to purchase a new optical scanning tabulator system for voting. The need to replace the current voting equipment (Accuvote) that had been purchased in 1997 and is in poor condition. These machines offer many new technology advantages. This purchase had previously been discussed with the Finance Committee during the budget discussion. Bids for these machines had been received this afternoon and there was only one bidder. This expenditure has to be approved by the Board of Selectmen by May 11 in order to

have them in place for the September primary and for the presidential election. Due to the time frame restrictions, it was decided that this expenditure should come our of the Reserve Fund rather than going through Capital. Board of Selectmen usually approves the Reserve Funds prior to submission to the Finance Committee, but due to time constraints it was suggested to approve the request subject to the Board of Selectmen approval.

Reserve Fund Update

Town Administrator spoke to meeting with Finance Director, Town Accountant and representatives of the Police and Fire Departments regarding potential budget shortfalls for FY2016 It is anticipated that there will be needed \$100,000 for Fire Overtime and \$20,000 for Police Overtime. At this time, he would like to leave monies in the Reserve Fund as it is unknown the amount of fires that could occur during he last two months of the fiscal year.

Finance Committee voted on March 31,2016 the amount of \$83,157,147 but did not vote the fund sources.
