## **Minutes**

### **April 3, 2017**

Regular meeting of the Finance Committee was held on Monday, April 3, 2017 at 7:00 p.m. in Room #112, Town Hall with the following members present: D. Bruce, J. Burke, E. Barmakian, T. Bowen, J. Johnson, Finance Director M. Thompson, Town Accountant J. Cuneo, and Fire Chief T. Bailey. Also in attendance was School Superintendent L. Lynch, Assistant Superintendent J. Kenney, School Committee Chairman N. Gallivan, School Committee Members and residents of the community.

7:00 p.m. – Quorum being present, the meeting was called to order by the Chairman D. Bruce.

### **Election of Finance Committee – Vice Chairman**

K. Guyette has stepped down as Vice Chairman and submitted his resignation from the Finance Committee to the Town Moderator T. Brady and Finance Committee Chairman D. Bruce. Vacancy now exists on the Committee and the Moderator is looking to fill the position.

Chairman asked for anyone interested in serving as Vice-Chairman. M. Trudell offered to fill the position.

#### **Town Administrator**

Town Administrator updated the Budget recommendations as of March 31, 2017. Additional money has become available due to increase in Health Insurance and Tri-County enrollment dropping. Committee had questions on Prison Mitigation monies, This will be Certified Free Cash next year. Town Administrator anticipates receiving it in August.

# **Employee Fringe Benefits**

## **Employee Retirement Assessment**

This budget had been put on hold due to Committee members having questions on the \$300,000 requested for the OPEB line item. Town Administrator spoke to this is the amount that the Town can afford at this time. Town is not required to put any money aside for it, but it is an unfunded liability facing the Town in the future. Town's Auditors and Bond Counsel are pleased that we are doing this. It helps the Town's ratings. He spoke to making another contribution to OPEB at the Fall Town Meeting if Free Cash is available. Town has been putting money into this account for 8 years.

Town Administrator is looking into increasing the percentage that retirees pay for senior supplements. (presently 50%) This has been brought before the Board of Selectmen, but no decision has been made. This will come before the Board of Selectmen after the election.

### **School Budget**

Discussion was open up on the School Budget. Town Administrator is recommending \$70,000 be placed in the School Budget to reduce the cost of FDK for the School Year 2017-2018. This represents 10% of the overall cost to eliminate the fees charged for this program. This will be revisited next year to determine if the Town can afford additional appropriations. This is a step in the right direction. The \$70,000 will reduce the amount paid now by about \$400. Superintendent Lynch spoke to this being helpful in reducing costs over a period of time, they hope to continue to work with Representatives, Senators and Governor to receive more state aid and be further helpful in their goals. Foundation Budget could be helpful with State Aid. This transition process, could take over ten years to full fund. Any members having questions, mail them to the Superintendent.

Committee members spoke to this being a long time coming and is needed for the 15% that don't have the opportunity to attend. This transition gets costs phased in.

Committee had questions on whether the \$400 reduction in tuition will encourage more people to be interested. There are costs savings with more participants and savings in other parts of the program. Walpole charges one of the highest in the State for Full Day Kindergarten.79% of the communities in the State don't charge for full day kindergarten. Some committee members like it being transitioned. There are many benefits to full day kindergarten. Most people are in favor even if they have to pay. Discussion is needed on what we can and can't afford. This is also represents an alternative to day care. What are

the actual costs and associated costs with ½ day kindergarten. It is difficult to understand the true costs. School Superintendent spoke to children need all types of services and a lot of costs go into it.

Chairman Bruce will ask the Moderator to write a letter to the members of the State Legislature regarding the Foundation Budget and to speak to it at Town Meeting.

Full Day Kindergarten began with private schools offering it, then the Towns began to offer it with a tuition charge. Town started a pilot group. Special needs students are mixed in. These students are not charged for it.

# <u>Article 32 – Walking Easement</u>

Conservation Commission voted 6-0-0 in favor of abandoning the easement as it was felt it does not hold a purpose nor is connected to the Town's trail system. There was some question whether this was part of the Planning Board's decision and whether it would need to be released by the Planning Board. What conditions, if any, were on the decision.

Town Administrator will check with Town Counsel on this. R. Nottebart will check this out with the Planning Board.
