Mr. Timson thanked all the town employees and inhabitants of the town dealing with the difficult weather. People have been keeping their whit's about them.

2-14 Trails Committee, Kate Notman

MOTION moved by Mrs. Mackenzie to appoint Kate Notman to the Walpole Trails Committee as a Regular Member, seconded by Mr. Snuffer, VOTED 5-0-0

2-15 <u>RTM Apportionment</u>

Mr. Fucile appeared before the Board to review the Apportionment . He is recommending they stay with the present apportionment. Mr. Snuffer has no issue with the proposal. They discussed the petition that is recommending to the Fall annual town Meeting to not include MCI. Mr. Fucile explained it requires a procedure which takes generally six months. Town Administrator's Report

T. Mtg Articles- would like to start to bring some to you for your review.

Capital Budget-updated, center Fire station partial roof replacement. The original request was \$310,000. It is actually \$30,000. I feel we will be keeping that building we should do that.

Budgets going forward is there a specific section of the budget you would like to talk about. Would you like to meet with a department head? How do you want to handle that?

Mr. Snuffer one thing I did, I attended the school budget meeting. Mr. Gallivan suggested he skim through that budget and identify areas you want to talk about we can add to the agenda. WCTV has expanded their board to ten and invited the public committee to join them. Would like to see most of the Boards and Committees on TV to watch and learn. This is an interim but it will be until their next election. Mrs. Mackenzie agreed it would be great to see some of the meetings on TV. It would be nice to not have to rely on second hand information.

Liquor License survey- Cindy and Liz are sending out the survey.

Community Dev Director- I attended the Planning Board meeting and they have agreed to go along with it. They have bought into the idea. Mrs. Mackenzie, that is huge, for years we have tried to get it to go this way. Good Job.

Snow and ice prior to this week's storm now \$110,000, that is an estimate. Identifying sources.

MEMA sent the NY department of transportation. They were here Friday helping. Mrs. Mackenzie spoke of the Fire hydrants if it is not on your property but on your neighbors. If we could all help each other out.

Mr. Johnson noted a lot of people are concerned about their roofs. Our own roofs we continue to monitor and we have cleared off all School roofs. The Governor is seeking emergency funds. We have sought funding from the first storm. We still have to pay upfront and then we would get reimbursed.

Solar- in the past we have not sought the benefits of solar. I would like you to reactivate the Pilot program committee again

Mr. Gallivan would like to see us take a look at the Lincoln Road Landfill, questions about the cap and what can be done there. The town of Dennis just put a massive solar project on their cap. The person Mr. Johnson met with said they wanted to check it out.

Mr. Johnson was also approached by Borrego Solar. Could be some savings for the Town of Walpole. There is a new proposal on Walpole Woodworkers meet with them next week. It is not affordable. 40 Condos and assisted living.

Mrs. Mackenzie talked about the pianos that are at the Schools. Maybe this is something someone may want to donate. We have a need for three good pianos.

OLD BUSINESS

The SWAP Colleberative continues to move forward. We have MAPC on Board and actual program, March 12 in Norfolk. We are at the point where we are executing another plan .

Chief Bailey we will take care of the hydrants that we can reach. Trying to get the word out and doing the best we can. Ran numbers 262 runs above last year. We have two

fires today and one on Sunday. Chief Bailey noted many times there are hydrants at the end of the cul-de-sac and we try to be sure there is at least one.

Mr. Gallivan noted there were three of the LOWES garden shops have collapsed. Chief Bailey noted the roofs are built to code but not this much snow.
