Town Forest Celebration

Gary Riggott, appeared before the Board to discuss their plans for the 100th Anniversary of the Town Forest. They are proposing an event for May 1, 2016, Sunday and hoping to open gates at 11am and conclude by 3pm. Steve Cyr, Paul Hunter, Bob LeBlanc, Patrick Shield, Roger Turner are involved. They are trying to get more publicity, fundraising, to execute the activities. Writing monthly articles in the Walpole times, good way to get their attention, updating the website, there was a Facebook page which Gary took that over and thinks Patrick will handle that. They have people with different skills. Fundraising, one at Conrads, a few other restaurants, lined up, Ravens nest, Finnegan's wake. Fundraiser with ever so humble pie, they are selling tarts. Celebration, plans are fluid, we talk about them each week, some speakers, put a monument on top of the existing. Dedicate an anniversary garden near white bridge. The industrial arts will create some benches for us. Plant a centennial tree, bouncy house, face painting, food trucks. Horse drawn carriage rides. Looking through the itinerary of the 50th and 75th. Getting ready contacting schools, creative activity contest. Some kids are into photo, drawing, have a wide interest and have them displayed near Turco field. Steve Cyr-stated phase 2. Talked about the timber harvest. Last winter tried to put phase 2 into action. Vote March 2015 to postpone the harvest because of the Mud season until this winter. Dan Reed logging, able to honor their quotes. Out there working now. A little bit of harvesting. Bulk of the work is where we started. About

26 acres mapped out. Break even operation for the T. Forest trust, by the time we pay the logger. We did not mark that much timber on phase 2. Post harvest walks took feedback from residents there. Less volume is less revenue. The work they did, skid trails, where the wood gets dragged to a landing. They have ordered 1,000 white pines and plant them on the west side of the work has been done. See if children will plant these trees.

Let people know we are out there. Hope to get a big turnout. Board members appreciate them logging the forest and to keep it going for another 100 years. Mr. Gallivan asked they forward the flyer to him and he can send it out in an email blast.

Mr. Salvatore suggested maybe families would be interested in buying the white pine seedlings to plant.
