Walpole Day will be held either May 17 or the 24th. Hopefully, all will be ready by then. That day would be a good time to publicly proclaim the volunteers. Price of the lights is double with LED lights.

Mr. Turner discussed inspecting the underside of the cannon for historical information. DPW might set up the second cannon at minimal cost. The first one was in the library construction budget.

The Master Plan required us to improve the downtown campus, expand usable green space, and maintain the water ways. The bridge connects the vastly improved field with unused town property on East Street. The Bay Circuit Trail Alliance has been helpful and supportive of this project. Town Hall and the business area are better connected. Lots of local services were donated including the Chamber of Commerce, NUASCE, and the Lions Club. The project was an \$80,000.00 value accomplished for approximately \$3,000.00.
