The individual has not appeared at any meetings. The night of the public hearing, Mr. Abbott was there and much opposed to this and offered logical commentary as to why this would confuse the situation.

Jim asked the Board not to vote on this article until we get closer to Town Meeting.

10-8 Environmental Protection Insurance, South St

David Labonte and Robin brought to our attention that we should have some insurance for the South St. site. We solicited multiple bids. I don't want to be the person to not recommend insurance. It probably is a good protection for the town.

Mr. Snuffer, questioned in choosing the bid you did vs the range which is substantial, have you endangered the liability coverage that we might need going forward.

Ms. Chapell explained the town has protected us with the covenant not to sue, the superfund laws the Federal government. But a third party can always sue us, worker, someone walking on our site. Mr. Labonte explained what the coverage would do. The limit is a 5million limit it is a 10 year policy. Chub has a good comfort level as to what they are insuring the town for.

Mr. Kraus asked Mr. Johnson if it is his recommendation for A &B Mr. Stanton questioned is there an attachment that shows a map. Mr. Johnson reported that MIIA asked for the Assessors card and he will ask David to include a map to show specifically where we are covered. Mr. Labonte stated that Chub has a good understanding of the boundaries of the site and they are comfortable with it. Ms. Salvatore questioned if the area under the rail bed is that included. Ms. Chapell stated yes, it is part of the superfund

site. So this covers if we spill something. Mr. Labonte stated they look to make sure the Town is protected.

Mr. Snuffer one reason he had questions, he had heard a person we have great respect say he does not think we really need insurance. This does not deter the Responsible Party from their responsibilities. The coverage will extend into the river area.

Mr. Gallivan hates spending this money on insurance. I am in favor of this. I do not like the idea of spending this kind of money.

MOTION moved by Mr. Kraus to authorize the Town Administrator to sign the agreement for Environmental insurance for the South Street Site for coverage A & B and for a map of the covered area to included in the agreement., Seconded by Mr. Gallivan, VOTED 5-0-0

10-9 Affordable Care Act Policy

This is a byproduct of Obama Care. Drafted by labor counsel. We are complying with the federal law. We know of no one that could be impacted by this. But we will keep an eye on this. It is possible that some may fall under the agreement. Mr. Snuffer stated what he has learned about the affordable care act is there is nothing that I trust.

They have to hit the twenty hours a week, 52 weeks a year. The School Committee supported this. What would happen if we do not adopt a policy? Mr. Johnson explained the feds are mandating we adopt a policy. Mr. Snuffer will be on the record as abstaining. Mr. Johnson noted that counsel stated this policy protects the town and schools for the lookback period. Mr. Gallivan explained parts of the ACT he has concerns but feels it is important to adopt the policy. As far as the 20hr and 30hr threshold, we will have to keep an eye on this. Mr. Johnson explained if we do not adopt this we could open ourselves up to a violation of the Affordable Care Act.
