# DECISION – WALPOLE BOARD OF APPEALS CASE NO. 05-18

### **APPLICANT**

Supa Cars, LLC.

## **LOCATION OF PROPERTY INVOLVED:**

1900 Main Street Assessors Map/Lot: 46-67 APPLICATION: TOWN OF WALPOIL

An Amendment to an existing Special Permit under Section 5-B-4.E. and a Special Permit under Section 5-B.4-D.D. of the Zoning Bylaws to allow the repair of outside cars, increase the number of cars parked on site, rental of U-Haul vehicles and metal crafting and body repair with no sanding or painting.

\*\*\*\*\*

On April 4, 2018 a Public Hearing was opened and was continued multiple times, on the expectation that the Applicant would provide additional information as requested by the Board. The hearing was last continued to January 2, 2019 at the Applicant's request to allow it time to provide the information requested by the Board. By certified letter dated December 17, 2018, the Board notified the Applicant that due to resignation of Board members, it no longer had a legal quorum sufficient to act on the Application, and recommended that the Applicant withdraw its application and resubmit to the newly-constituted Board. The letter informed the Applicant that the Board would be forced to deny the Application if it was not withdrawn. On January 2, 2019, the public hearing was re-opened in the Main Meeting Room of Town Hall and then closed for the purpose of deliberating and voting upon a decision on the application. The Applicant did not attend the January 2, 2019 public hearing and did not submit any further information for the Board's consideration. The Applicant did not seek to withdraw and did not submit a new application. The members who were present and voting:

#### **VOTE OF THE BOARD:**

A motion was made by Ms. Murphy and seconded by Mr. Fitzgerald to deny the application for an amendment to an existing Special Permit under Section 5-B-4.E. and a Special Permit under Section 5-B.4-D.D. of the Zoning Bylaws to allow the repair of outside cars, increase the number of cars parked on site, rental of U-Haul vehicles and metal crafting and body repair with no sanding or painting, at 1900 Main Street, Walpole, MA 02081.

The vote was three (3) in favor, zero (0) opposed and three (3) abstained (3-0-3) to deny the application (Mr. Lee, Ms. Murphy, Mr. Fitzgerald in favor; Ms. Coffey, Mr. Merrikin, Mr. Delaney abstained due to the fact that they were not eligible to sit on the case), therefore, the Amendment to the existing Special Permit and Special Permit under Sections 5-B-4.E and 5-B.4-D-D. was hereby denied.

#### REASONS FOR DECISION

It is the finding of the Board that the Applicant was unable to meet the requirements of Sections 5-B-4.E and 5-B.4-D-D., due to lack of information submitted and the subsequent failure to meet the requirements for provision of a Special Permit. The Applicant did not attend the January 2, 2019 hearing, did not request a continuance, and did not supply the information previously requested by the Board or otherwise to advance its case. Further, because of resignation of Board members, the Board lacked the legal authority to approve the Application, and no action short of withdrawal of the Application and resubmission would allow the Board to grant the requested approvals.
